A perusal of the counter and the submissions made by the learned Additional Government Pleader reveals that on receipt of the representation from the petitioner, the respondents visited to Kaboor Bai Street and inspected the same. It is found that the drainage water overflows from one Sivagami's house into the street. On the day itself, the hole was closed and the allegations made by the petitioner were rectified. Now, there is no overflow of drainage water in the street and no hindrance to the public.
