This writ petition has been filed by the petitioner for issuance of a writ of mandamus directing respondents 1 to 8 to take immediate steps to remove the encroachment made by the 9th respondent and his supporters in S.F.No.93, classified as "Oodai" and further classified as "Sarkar Poramboke" in the resurvey measuring an extent of 0.44.5 Hectares situated at Vellaraveli Village, Uthukuli Taluk, Tiruppur District by considering the petitioner's representation dated 24.5.2024.

2. Mr.Habeeb Rahman, learned Government Advocate, who accepts notice on behalf of respondents 1 to 8, submits that the respondent authorities shall pass orders on the representation of the
