The grievance of the petitioner is that though he has given an online application on 05.04.2024 by paying necessary fees for surveying his property and fix the boundaries, the respondents have not considered the same. Hence, the present Writ Petition.

Considering the limited relief sought for in this writ petition, the respondents are directed to consider the representation of the petitioner dated 05.04.2024 and pass appropriate orders on the same, after giving notice to the neighbouring land owners and any other interested persons, within a period of two months from the date of receipt of a copy of this order.

6. With the above direction, this writ petition is disposed of. No costs.
