JUDGMENT

This Criminal Original Petition has been filed to expedite the trial in C.C.No.5061 of 2016 pending on the file of the learned Additional Chief Metropolitan Magistrate, Egmore.

2. The petitioner is facing trial in C.C.No.5061 of 2016 on the file of the Additional Chief Metropolitan Magistrate, Egmore for the offences under Sections 120(B) r/w 193, 211, 469 r/w 471 of IPC.

3.The petitioner who is a party-in-person appeared before this Court and submitted that out of 60 witnesses, only 31 witnesses have been examined. Since this Court, by an order dated 08.08.2023 in Crl.O.P.No.5269 of 2023, directed the trial Court to expedite the trial and complete it within reasonable time, the trial has not been completed till date. Hence, the present petition has been filed seeking a direction to the learned Chief Judicial Magistrate to expedite the trial proceedings.

4.The learned Special Public Prosecutor for CBI submitted that sincere efforts are being made from the side of the prosecution to conclude the trial at the earliest and the case is at the stage of prosecution evidence. Hence, there may be a direction to the concerned Judge to complete the trial by six months.

5.Heard the petitioner/party-in-person and the learned special Public Prosecutor for CBI and also perused the materials available on record.

6. It is seen from the records that the case is of the year 2014 and the final report filed by the respondent has been taken up for trial in C.C.No.5061 of 2016. Despite lapse of almost 8 years, the case has not come to a logical end. Hence, this Court directs the learned Trial Judge to complete the trial as expeditiously as possible, without giving any unnecessary adjournments to either side, preferably within a period of 6 months from the date of receipt of a copy of this order.
