2. The petitioner submitted a representation on 11.12.2023 with a request for surveying the petitioner's property, however, the same is pending without consideration till date. Hence, this writ petition.

3. Heard both sides and perused the materials available on record.

4. By consent of both parties, this writ petition is taken up for final disposal at the admission stage itself.

5. Considering the limited relief sought for in this writ petition, the first respondent is directed to consider the representation of the petitioner dated 11.12.2023 and pass appropriate orders on its own merits and in accordance
