3. When the matter is taken up for hearing, the petitioners and the defacto complainant have appeared before this Court along with their respective counsels. This Court have enquired both parties, the defacto complainant stated that she is not inclined to proceed with the complaint and want to withdraw the proceedings against the petitioners.
