Prayer: Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus, calling for the entire records which culminated in passing the proceedings in Se.Mu.Na.Ka.No.R1/13514/2017 dated 21.08.2018 on the file of the first respondent, confirming the order passed by the second respondent/appellate authority in proceedings in Se.Moo.No.252/2017/A dated 05.03.2018 and the order passed by the 2nd respondent in his proceedings Na.Ka.No.252/2017/A dated 05.03.2018, and the order passed by the 3rd respondent in his proceedings Na.Ka.No.1234/B1/CV/2017 dated 12.12.2017, quash all the aforesaid orders and consequently, direct the respondents to reinstate the petitioner in service as Salesman in any of the TASMALC shops within Namakkal District.
