2. This Writ Petition is filed to direct the second respondent to issue patta to the petitioner by considering the representation of the petitioner dated 12.06.2023.

3. Heard the learned counsel for the petitioner and the learned Special Government Pleader for the respondents 1 to 4 and perused the materials available on record.

The grievance of the petitioner is that he made representation before the second respondent to issue patta for his property in Survey No.39, measuring an extent of 1.34 acres, situated at Battavarapalli Village, Bellathur Post, Hosur Taluk, Krishnagiri District. However, the same has not been considered by the second respondent. Hence, the present Writ Petition.
