calling for the records of the first respondent in G.O.Ms.No.44, Finance (Pay Cell) Department, dated 18.02.2014 in so far as it extends the monetary benefit of revision of pay scale from Rs.5,200/20,200 + Grade Pay of Rs.2,000/- to Rs.5,200-20,200 + Grade Pay of Rs.2,400/- with monetary benefits from 01.12.2013 alone and quash the same and consequently direct the first respondent to treat the post of Junior Inspector of Sericulture on par with the post of Junior Assistant/Village Administrative Officer/Drivers and extend the monetary benefits of pay revision with effect from 01.02.2011 / 01.03.2011 to the post of Junior Inspector Sericulture.
