3. The fifth respondent School is a minority institution under Article 30(1) of the Constitution of India. The petitioner was appointed in the regular sanctioned post with grant-in-aid by the Government. The staff fixation of the fifth respondent School for the academic years 2019-2020 to 2023-2024 revealed that the eligibility for the said post from the records issued by the competent educational authorities. Thereafter, the fifth respondent had sent a proposal for approval of appointment of the petitioner to the post of BT Assistant (Social Science) with effect from 04.06.2020. However, it is still pending with the fourth respondent.

In view of the above, the fourth respondent is directed to consider the proposal sent by the fifth respondent for approval of appointment of the petitioner to the post of BT Assistant (Social Science) and pass appropriate orders on merits and in accordance with law within a period of eight weeks from the date of receipt of a copy of this order.
