Writ Petition filed under Article 226 of the Constitution of India seeking a writ of mandamus directing the 4th respondent to permit all the south bound buses of the 11th to 17th respondents to pick up and drop passengers at Koyambedu Chennai Mofussil Bus Terminus (CMBT-Koyambedu), Koyambedu Chennai Contract Carriage Bus Terminus, Maduravoyal, Vanagaram Toll Plaza (Porur Toll Plaza), Perungalathur and to restrict trucks, multi-axle, heavy and medium commercial vehicles to ply via Vandalur and Perungalathur in GST Road /NH32 Vanagaram Toll Gate (Porur Toll Gate) to minimise traffic until build a U turn flyover to allow vehicles moving from KCBT-Kilambakkam Bus terminus towards Perungalathur, build a new sub urban Railway station at Kilambakkam with a sky walk to the KCBT-Kilambakkam Bus Terminus, Construction of Metro Rail Line Project from Chennai Airport to the KCBT-Kilambakkam Bus Terminus

and New Metro Rail Line between Velachery and Tambaram, as planned.
