When the matter is taken up for hearing, learned Additional Government Pleader representing the respondent has submitted that the Government has issued orders fixing the pay of all the petitioners in accordance with G.O.Ms.No.451 Finance (Pay Cell) Department dated 31.12.2010 as sought for by the petitioners. Copies of the proceedings have been circulated to learned counsel for the petitioners. Once the pay of the petitioners has already been fixed as sought for in this Writ Petition, cause does not survive to the petitioners to prosecute this Writ Petition. In view of the above, the Writ Petition will not survive.

Accordingly, the Writ Petition is disposed of. No costs.
