Considering the limited nature of the relief sought for in the present Writ Petition, there shall be a direction to the respondents to consider the representation of the petitioner dated 09.02.2024 and pass appropriate orders on merits and in accordance with law as expeditiously as possible, after enquiring necessary parties, if necessary to proceed as per law.
