The learned Special Government Pleader appearing for the respondents submitted that already the petitioner had challenged the G.O.No.8, dated 31.01.2013 in W.P.No.27537 of 2014, which is pending before this Court. Therefore, the representation submitted by the petitioner can be considered only subject to the result of the said writ petition.

3. In view of the above, the representation submitted by the petitioner cannot be considered. However, the petitioner is at liberty to submit a fresh representation subject to the result of the W.P.No.27537 of 2014.
