ORDER

In view of the limited request made by the learned counsel appearing for the petitioner, this Court, without interfering with the impugned order dated 13.03.2023, permits the petitioner to make a fresh application before the second respondent along with the requirements as sought for by the second respondent and on receipt of the application, the second respondent is directed to consider the same and pass appropriate orders as expeditiously as possible.
