No.101/2 vide Patta No.495, situated at Periyakallipatti Village, Sathyamangalam Taluk, Erode District, within Registration District of Gobichettipalayam, and Sub Registration District of Punjaipuliampatti, lying within Bhavanisagar Panchayat Union limit, on merits and in accordance with law, after giving notice to the petitioner and any other interested persons. Such exercise shall be completed within a period of two months from the date of receipt of copy of this order.
