3. Subsequently, a memo of compromise has been filed by the first petitioner/Karthick and the sole respondent/Padmasri. In terms of the compromise, the parties have agreed to re-concile the differences and re-commence cohabitation. The respondent/Padmasri is present before the court and so is Karthick.

4. Padmasri is clear and categorical that she will withdraw DVC.No.17 of 2023 on the file of the Judicial Magistrate Court-I at Mayiladuthurai. She states that she is unable to withdraw the proceedings only on account of the interim order granted by this Court on 23.08.2023.

5. I have gone through the memo of compromise.

6. I do not find anything illegal or contrary to law. Both the parties who are present and whose identities have also been verified, confirmed that they
