Hence, the petitioner seeks a direction to consider the representation dated 31.07.2023 and to direct the first respondent to register the document.

3. The learned Additional Government Pleader appearing for the respondents on instructions would submit that the document has not been presented and let the petitioner present the document before the concerned Sub Registrar, the same will be considered as per law.

4. Heard the learned counsel for the petitioner and the learned Additional Government Pleader for the respondents and perused the materials available on record.
