Considering the limited nature of the relief sought for in the present Writ Petition, there shall be a direction to the second respondent to dispose of the appeal filed by the petitioner dated 11.11.2022 and pass appropriate orders, on its own merits and in accordance with law, within a period of two months from the date of receipt of a copy of this order.

7. With the above direction, this Writ Petition is disposed of. No costs.
