2. Today, the matter is listed under the caption “for being mentioned”.

2.During the course of hearing, it was agreed by parties that the parties will maintain status *quo* as on date till the disposal of the suit in C.S.No.678 of 2019. The learned counsel appearing on either side then submitted that a direction may also be issued to expedite the trial and to dispose of the suit within a period stipulated by this Court.

3.Considering the submissions of the learned counsel on either sides, this Court is inclined to modify Para No.3 of the common judgment dated 09.08.2024 in O.S.A.Nos.148 and 149 of 2023. Accordingly, the following paragraph shall be substituted in the place of Para No.3 in the judgment dated 09.08.2024 in O.S.A.Nos.148 and 149 of 2023.

“3.Since the parties agree for early disposal of the suit and

that status *quo* will be maintained by the parties till the disposal of the suit, these Original Side Appeals are disposed of with the following directions :

- (a) The suit in C.S.No.678 of 2019 shall be listed for trial within a period of three months from the date of receipt of a copy of this judgment and there shall be endurance by Court to dispose of the same on merits, as expeditiously as possible, preferably within a period of six months from the date of receipt of a copy of this judgment.
- (b) The parties are directed to maintain status *quo* as on date till the disposal of the suit.
- (c) There shall be no order as to costs. Consequently, connected miscellaneous petitions are closed.”
