Prayer: Writ Petition filed under Article 226 of the Constitution of India for issuance of a Writ of Certiorified Mandamus, calling for the records relating to the impugned communication dated 26.04.2023 issued by the 2nd respondent refusing to pay the insurance claim to the petitioner and quash the same and consequently direct the 2nd respondent to settle the insurance claim
