ORDER

This Criminal Original Petition is filed to quash the F.I.R., in Crime No.0127 of 2024 dated 19.06.2024 on the file of the Inspector of Police, Orleanpet, Puducherry.

2. Learned counsel for the petitioner submitted that without any *prima facie* evidence, only based on the complaint given by one Sagunthala Devi/second respondent herein, the first respondent/Police registered the case in Crime No.0127 of 2024 against the petitioner. Therefore, he prays to quash the F.I.R in Crime No.0127/2024.

3. Learned Additional Public Prosecutor (Puducherry) appearing for the first respondent submitted that on completion of investigation in Crime No.0127 of 2024, final report has been placed before the Director of Prosecution, Law Department, Puducherry for obtaining legal guidance, in order to finalise the case at the earliest.
