Till the conclusion of enquiry, the respondents 1 to 3 shall not pass an order of approval to the respondents 4 & 5 school.

4. With the above directions, the Writ Petition stands disposed. Consequently, connected miscellaneous petition is closed. There shall be no orders as to costs.
