2. This Writ Petition has been filed to direct the third respondent to dispose of the petitioner's representation dated 04.08.2022 within a stipulated time that may be fixed by this Court.

3. The petitioner owned the land by way of a partition deed entered into between the family members of the petitioner dated 20.07.2006, registered vide Document No. 1519 of 2006. Thereafter, the petitioner applied for a separate patta for the share allotted in favour of the petitioner, to an extent of 1480 sq.ft (3.394 cents), comprised in S. No. 568C/1 with a building situated in Vikravandi West Village, Viluppuram District. Therefore, the petitioner submitted the said representation for the issuance of a separate patta for her share, and the same is pending on the file of the third
