

**Crl.O.P.No.16956 of 2024****T.V.THAMILSELVI, J.**

Today, this matter is listed under the caption 'For Reporting Compliance'.

2. The learned counsel appearing for the petitioner submits that the petitioner had complied with the condition imposed on the petitioner by this Court vide Order dated 19.07.2024.

3. The learned Government Advocate (Criminal Side) also submits that the petitioner had complied with the condition of depositing Rs.1,00,000/- in Crime No.116 of 2024 imposed by this Court.

4. Recording the submission of the learned Government Advocate (Criminal Side) and the fact that the petitioner had complied with the condition of deposit, this Court is inclined to grant **anticipatory bail** to the petitioner with certain conditions.

5. Accordingly, the petitioner is ordered to be released on bail in the event of arrest or on his appearance, within a period of fifteen (15) days from the date of receipt of a copy of this order before the ***learned Judicial Magistrate II, Tambaram*** on condition that the petitioner shall execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand Only), with two sureties, each for a like sum to the satisfaction of the respondent police or the police officer who intends to arrest or to the satisfaction of the learned Magistrate concerned and on further condition that:

[a] the sureties shall affix his photographs and Left Thumb Impression in the surety bond and the Magistrate may obtain a copy of his Aadhar card or Bank pass Book to ensure his identity.

[b] the petitioner shall report before the respondent police as and when required for interrogation.

[c] the petitioner shall not abscond either during investigation or trial.

[d] the petitioner shall not tamper with evidence or witness either during investigation or trial.

[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioners in accordance with law as if the conditions have been imposed and the petitioners released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in *P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560]*.

[f] If the accused thereafter absconds, a fresh FIR can be registered under Section 229A IPC.
