Prayer: Writ Petition filed under Article 226 of the Constitution of India, praying to issue a Writ of Mandamus, directing the respondents herein to survey and measure the property comprised in S.No.69/1, Patta No.817, admeasuring to an extent 0.05.5 Hector or 0.13 Cent, the property situate at Keezh Alathur Village, K.V.Kuppam Taluk, Vellore District and to fix the boundaries so as to fence the property, based on the petitioner's representation dated 01.07.2024 and consequently, the respondents submit the report and handover to the petitioner.

ORDER

By consent of both sides, this Writ Petition is disposed of at the stage of admission itself.

2. This Writ Petition is filed to direct the respondents to survey and fix the boundaries of the petitioner's land comprised in S.No.69/1, Patta No.817, measuring an extent of 0.05.5 Hector or 0.13 Cent, situated at Keezh Alathur Village, K.V.Kuppam Taluk, Vellore District, by considering the petitioner's representation dated 01.07.2024.

3. Heard the learned counsel for the petitioner and the learned Special Government Pleader for the respondents and perused the materials available on record.

4. The grievance of the petitioner is that she has paid the requisite fees to survey the property and demarcate its boundaries in S.No.69/1, Patta



No.817, situated at Keezh Alathur Village, K.V.Kuppam Taluk, Vellore

District. However, the same has not been considered by the respondents.

Hence, she seeks a direction.

5. Considering the limited nature of the relief sought for in the present Writ Petition, there shall be a direction to the respondents to consider the petitioner's representation dated 01.07.2024 and pass appropriate orders, for survey of the property and demarcate its boundaries, after giving notice to the neighbouring land owners and any other interested persons, within a period of two months from the date of receipt of a copy of this order.

6. With the above direction, this Writ Petition is disposed of. No costs.
