The learned Standing Counsel appearing on behalf of the respondents would submit that the application submitted by the petitioner seeking electricity service connection was cancelled, since the petitioner has produced an unregistered Sale Deed. The petitioner has to submit other relevant documents to the satisfaction of the Competent Authorities for the purpose of considering the application.

3. Since the application submitted by the petitioner has already been cancelled for want of necessary documents, the relief as such sought for in the present writ petition cannot be granted. However, the petitioner is at liberty to submit all the relevant documents by approaching the Competent Authorities for providing electricity service connection.



4. With the above liberty, the present writ petition stands disposed of. However, there shall be no order as to costs.
