We have heard Mr.K.Govi Ganesan, learned counsel for the petitioner, Mr.P.Harish, learned Government Advocate for respondents 1 to 4 and Mr.D.R.Arun Kumar, learned counsel appearing for the fifth respondent.

2. The petitioner seeks direction upon respondents 1 to 4 to remove the encroachments and unauthorised construction put up by the fifth respondent in S.F.No.248, Idikarai Village, Annur Taluk, Coimbatore District.

3. The learned Government Advocate submits that on receipt of complaint from the petitioner, direction was issued to the fifth respondent to stop the construction.

4. The learned counsel for the fifth respondent submits that the
