This case came up for settlement before the National Lok Adalat. Both the parties are present. **Mr.S.P.Yuaraj**, learned counsel for the appellant and **Ms.V.Vikma for Mr.J.Michael Visuvasam**, learned counsel for the second respondent are present. After mutual discussion, negotiation, mediation and conciliation between both parties, they arrived at a compromise to settle the matter as follows:



TERMS OF SETTLEMENT

The Tribunal has awarded a sum of **Rs.18,89,856/- (Rupees Eighteen Lakhs and Eighty Nine Thousand Eight Hundred and Fifty Six Rupees only)** together with interest at the rate of 7.5% p.a. from the date of petition till the date of deposit of compensation. Having not been satisfied with the award, the claimant had filed the appeal before this Court.

2. Today the appellant/claimant and the learned counsel representing the second respondent/Insurance Company are present before the Lok Adalat. Today, the parties have agreed to settle the entire dispute on further payment of **Rs.23,00,000/- (Rupees Twenty Three Lakhs only)** in full quit.

3. Accordingly, the sum of **Rs.23,00,000/- (Rupees Twenty Three Lakhs only)** shall be deposited before the **Motor Accident Claims Tribunal, Special Sub Court, Krishnagiri**, within a period of **four** weeks from the date of receipt of a copy of this order. The claimant is permitted to withdraw the said amount.
