2. Objection is raised to the establishment of a TASMAL liquor shop on a wet land. Learned counsel for the petitioner submits that RTI information reveals that no permission has been obtained for construction of the TASMAL shop at the said place.

3. In case the petitioner has objection with regard to the running of TASMAL shop, then objection/appeal can be filed before

the District Collector under Rule 9 of the Tamil Nadu Liquor Retail Vending (in Shops and Bars) Rules, 2003. It is for the petitioner to avail the said remedy. In case the petitioner files an objection/appeal, in that event all objections are kept open.
