5. It is submitted that a survey was conducted on 05.01.2023 and the present state on ground details of the above lands are furnished below:

144	Kulam (Pond)	1.66.5	Pathway to kulam in layout 40 sq metre
147	Vaikkal (Channel)	0.18.5	Encroachment in pathway of about 0.10.0 Hectare was surveyed and evicted on 13.01.2023 and there is no encroachment in the remaining 0.08.5 Hectare of land.
151	Vaikkal (Channel)	0.16.5	Outer Ring Road of about 0.08.0 Hectare and there is no encroachment in the remaining 0.08.5 Hectare of land
230	Eri (Tank)	15.29.5	Outer Ring Road of about 0.40.0 Hectare and there is no encroachment in the remaining extent of land.
