JUDGMENT

(Judgment of the Court was delivered by *D.KRISHNAKUMAR, J.*)

These Writ Appeals are filed against the order of the learned Single Judge in WP Nos.10702 of 2023, 10682 of 2023 and 10688 of 2023 dated 25.03.2024.
