2. Mr.K.Raja, learned Standing Counsel takes notice for the first and second respondents and Mr. C.S.K.Sathish, learned Standing Counsel takes notice for the third respondent. They would submit that the eligible amount will be paid to the petitioner within a reasonable time as may be fixed by this Court.

3. It is also brought to the notice of this Court by the learned counsel on either side that in all the similar matters, interest at the rate of 6% has been ordered by this Court.

4. In that view of the matter, this Writ Petition is disposed of on the following terms:

(i) the respondents are directed to pay interest on the belated payment of interest amount of provident fund, gratuity, earned leave salary commutation and other unsettle benefits of arrears of surrender leave salary for the years of 2009-2011 & 2017-2018 and 12th wage settlement arrears with effect from 21.08.2022 at the rate of 6% per annum, from the date on which the amount became due, till the date of disbursement, within a period
