The writ petition has been instituted challenging the Recruitment Notification No.159 of 2022 dated 24.07.2022 for recruitment to the post of Examiner, Reader, Senior Bailiff and Xerox Operator in Subordinate Judicial Service for the Dindigul District, Tamil Nadu.

2. Admittedly, the recruitment process had been completed and selected candidates were appointed and serving. Therefore, the writ petition deserves no further adjudication, since the challenge made is the recruitment

notification. However, the petitioner is at liberty to challenge the appointment orders, if it had been issued in violation of law.
