petitioner and the said Kalaimani is purely civil in nature and money dispute,

2. The learned Government Advocate (Crl.Side) submits that
pursuant to the complaint received from Kalaimani, the petitioner was
summoned on 3.05.2024 and 03.06.2024 and thereafter, the complaint was
