3. The issue involved in the present writ petition was dealt within the earlier writ petition in W.P.No.9394 of 2024 dated 10.04.2024. This Court, after considering the earlier order passed in this regard, issued direction to the concerned Regional Transport Officer. In the result, this writ petition is disposed of with a direction to the respondent to receive the application of the petitioner dated 15.07.2024 in form CCPA along with the prescribed fee paid by the petitioner through online for the grant of Auto rickshaw permit and consider the same on its own merits and in accordance with law and pass appropriate orders, within a period of six weeks from the date of receipt
