According to the petitioner, he has been in possession and enjoyment of the land in S.No.66/2 Mask Street, Kadakalthouppu Village, Gingee Taluk, Villupuram District, for the past 50 years, by virtue of long possession. The petitioner submitted a representation to the respondents 07.07.2024 seeking issuance of patta, the same has not been considered. Hence, the petitioner is before this Court.

3. Mr.U.Baranidharan, learned Additional Government Pleader, who takes notice for the respondents 1 to 5 would submit that the representation of the petitioner would be considered on its own merits, within a time frame fixed by this Court.

4. In view of the same, without going into the merits of the claim made by the petitioner, this Court is inclined to issue a direction to the second respondent to consider the representation of the petitioner dated 07.07.2024, and pass final orders, within a period of six weeks from the date of receipt of copy of this order.
