ORDER

The petitioner herein seeks a direction to the 2nd respondent to complete enquiry and pass final orders in appeal filed by her dated 09.05.2024.

2. The petitioner submitted an application dated 29.12.2023 before the 4th respondent seeking transfer of patta. The said application was rejected by the 4th respondent vide his Proceedings No.2023/0105/05/262948, dated 28.02.2024.
