ORDER

The petitioner has filed this writ petition seeking issuance of Writ of Mandamus directing the first respondent to direct the second respondent to issue transfer certificate and to return 1)10th standard original mark sheet, 2)11th standard original mark sheet, 3)12th standard original mark sheet, 4)original Transfer Certificate from previous institution and 5)original Community Certificate; to the petitioner, based on the representation of the petitioner dated 10.07.2024.

2.The learned counsel appearing for the petitioner submitted that the petitioner was studying B.Sc. Degree in Nursing Course in the second respondent educational Institution and she could not pursue her degree further inspite of paying the fee of Rs.75,000/-, however, the second respondent did not return the petitioner's original certificates submitted by her in the college at the time of admission.
