PRAYER: Writ Petition is filed under Article 226 of the Constitution of

India, to issue a Writ of Mandamus, directing the 1st respondent to pass an arbitration award on the appeal/claim petition dated 26.09.2022 within a stipulated period of time, by appointing competent engineers / officials for assessing the value of the land measuring an extent of 202 Sq. mtrs. in S.No.110/1, 745 Sq.mtrs. in S.No.233/2 and 83 Sq. mtrs. in S.No.234/1B at Uddanpalli Village, Shoolagiri Taluk, Krishnagiri District, and Structure (Buildings) and Trees, by strictly following the procedure contemplated under Section 26 to 30 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013) and also following the procedures contemplated under Section 18 to 27 of the Arbitration and Conciliation Act, 1996.

ORDER

The petitioner herein seeks a direction to the 1st respondent to pass arbitral award on his claim petition dated 26.09.2022 seeking an enhancement of the compensation payable to the petitioner in respect of the petitioner's land in Survey Nos.110/1, 233/2 and 234/1B at Uddanpalli Village, Shoolagiri Taluk, Krishnagiri District, acquired for the purpose of

extension of NH-844.

2. According to the petitioner, he is the owner of 1 Acre 14 cents in S.No.233/2, 1 Acre 3 cents in S.No.234/1B and 5 cents in S.No.110/1, situated at Uddanpalli Village, Shoolagiri Taluk, Shoolagiri Taluk, Krishnagiri District. A portion of the said land was acquired by the 2nd respondent for the purpose of laying four-way road-Hosur-Rayakottai-Dharmapuri, under N.H.844. The competent authority viz., the 2nd respondent fixed the compensation and passed an order on 29.01.2022. Not satisfied with the quantum of compensation fixed by the 2nd respondent-competent authority, the petitioner filed a claim petition dated 26.09.2022, seeking enhancement of compensation. The matter was referred to arbitration by the 1st respondent and the claim petition of the petitioner dated 26.09.2022 is pending on the file of the 1st respondent without any orders. Aggrieved by the same, the petitioner is before this Court.

3. Mr.A.Selvendran, learned Special Government Pleader, takes notice for respondents 1 to 3 and Mrs.S.R.Sumathy, learned standing counsel for National Highways, takes notice for 4th respondent.

4. The learned Special Government Pleader appearing for the 1st respondent would submit that the arbitration proceedings pending on the file of the 1st respondent would be completed within the time limit stipulated by this Court.

5. In view of the same, without going into the merits of the claim petition, this Court is inclined to direct the 1st respondent to complete the arbitral proceedings and pass the final award within a period of six months from the date of receipt of a copy of this order.

6. With this direction, the Writ Petition stands disposed of. No costs.
