ORDER

2. The petitioner herein submitted an application on 22.04.2024 for surveying the above mentioned land and for fixation of boundary stones. The application of the petitioner has not been considered by the respondents till date. Therefore, the petitioner is before this Court.

3. Mr.A.Selvendran, learned Special Government Pleader, who is taking notice for the respondents would submit that the application of the petitioner dated 22.04.2024 will be considered on its own merit by the 2nd respondent within the time fixed by this Court.
