### **ORDER**

The petitioner herein seeks a direction to 1<sup>st</sup> respondent to survey her agricultural land comprised in Survey Nos.17/2A1 and 17/2A2 at Navalur Village, Thalaivasal Taluk, Salem District by considering her online application dated 12.04.2024.

2. According to the petitioner, the above mentioned property belonged to her and she submitted an online application on 12.04.2024 seeking survey of the land and the same has not been considered by the respondents.

3. Mr.A.Selvendran, learned Special Government Pleader takes notice for the 1<sup>st</sup> respondent and Mr.S.Sugendran, learned Additional Public Prosecutor takes notice for the 2<sup>nd</sup> respondent.

4. The learned Special Government Pleader, who is taking notice for the 1<sup>st</sup> respondent submitted that the online application of the petitioner will be considered on its' own merits within a time fixed by this Court.
