Kathirampatti” with Road Code No.R96, as sanctioned under the proceedings of 1st respondent in Na.Ka.No.2350/2015/Aa11 dated 04.08.2015 under Tamil Nadu Rural Road Improvement Scheme 2015-2016.

2. Heard the learned counsel appearing for the petitioner and the learned Additional Government Pleader appearing for the respondents and perused the materials available on record.

3. On instructions, the learned Additional Government Pleader appearing for the respondents submitted that the said work is yet to start. Since the writ petition was filed before this Court in W.P.No.36135 of 2015, subsequently, it was withdrawn on 27.01.2022.
