ORDER

Therefore, this Court suo motu impleads the Revenue Divisional Officer, Gingee, Villupuram, as the 8th respondent in the present Writ Petition.

3. The learned Additional Government Pleader would submit that on the application being made before the 8th respondent, the 8th respondent will consider the application and pass orders.
