2. The learned Government Advocate (Crl.Side) appearing for the respondent police submits that there are six accused in this case, the prosecution proposed to examine 18 witnesses. Since the discharge petition filed by the accused persons, for the past two years trial not commenced. He further submits that the petition filed to discharge was dismissed recently and the case is posted to 06.09.2024 for framing of charges.
