This Criminal Original Petition is filed to transfer the investigation in Cr.No.142 of 2024 on the file of Chitlapakkam Police Station, Chennai to some other Police Officer, since the petitioner who is the complainant is not satisfied in the manner known to which, the Investigating Officer handling this case.

2. However, the learned Government Advocate (Crl.Side) states that the petitioner herein claims that he is having CC.Tv footage of the occurrence and the suspect one Vijaya Kumar who is tenant under him.
