ORDER

By consent of both the learned counsel appearing for the petitioner as well as respondents, this writ petition is disposed of at the admission stage itself.

2. The petitioner herein seeks a direction to respondents to consider his representation dated 25.07.2024 seeking issuance of patta in respect of property bearing Plot No.92, Survey No.29/1A, 31/2B Kizhanakarai Village, Pudiya Theru, Thiruvannamalai Taluk, Thiruvannamalai district.

3. It is the case of the petitioner that he purchased the above mentioned property from one Karuppan, S/o Chinnapaiyan under registered sale deed dated 29.09.2010 registered as Document No.9565/2010 on the file of Joint Sub-Registrar-II, Tiruvannamalai and has been in possession and enjoyment of the same for the past 15 years. The petitioner submitted a representation to 1st respondent on 25.07.2024 seeking issuance of patta in his name with copy marked to 2nd respondent and the same has not been considered by the respondents till date.
