ORDER

This writ petition has been filed seeking issuance of a writ of mandamus directing the respondents to pay the admitted amount of Rs.30,479/- to the first petitioner, Rs.26,925/- to the second petitioner, Rs.27,751/- to the third petitioner, Rs.12,791/- to the fourth petitioner, Rs.22,704/- to the fifth petitioner and Rs.30,289/- to the sixth petitioner towards encashment of earned leave surrendered by the petitioners along with 12% interest p.a. from the date of retirement.

2. Heard Mr.N.K.Ponraj, learned counsel for petitioners and Mr.M.Murali Vinodh, learned Standing Counsel appearing for respondents.



3. The case of the petitioners is that the petitioners are retired employees of the respondent corporation. The first petitioner retired from service on 01.07.2019 as Special Grade Conductor, the second petitioner retired from service on 21.02.2014 as Senior Assistant, the third petitioner retired from service on 30.06.2012 as Senior Assistant, the fourth petitioner retired from service on 21.02.2012 as Superintendent, the fifth petitioner retired from service on 10.06.2012 as Selection Grade Typist and the sixth petitioner retired from service on 29.07.2019 as Senior Conductor.

4. The grievance of the petitioners is that the respondents have not settled the encashment of earned leave surrendered by the petitioners. In view of the same, the petitioners made several requests to the respondents to pay the amount. Since the same was not considered, the petitioners made an application under the Right to Information Act, 2005. The respondents, by reply, have admitted that they have to pay the aforesaid amount to the petitioners. Even thereafter, the respondents have not come forward to pay the amount. Hence, the present writ petition has been filed.

5. Taking into consideration the facts and circumstances of the case and the grievance expressed by the petitioners, there shall be a direction to the respondents to pay the eligible and admissible amount with interest at the rate of 6% p.a. for the belated payment to the petitioners within a period of six (6) weeks from the date of receipt of a copy of this order. It is made clear that if the amount is not paid within the time frame fixed by this Court, it will fetch interest at the rate of 12% p.a. from the date on which the amount became due and payable till the date of actual realisation.

6. The petitioners are directed to submit a fresh representation to the respondents along with a copy of this order.

This Writ Petition is disposed of with the above direction. No costs.
