ORDER

The petitioners herein seek a direction to 2nd respondent to survey and demarcate their property in Survey No. 145/3, Town Survey no. 2/48 situated at Plot.No.10, 3rd cross street, 1st Main Road, Gopalapuram, Pattabiram, Chennai.

According to the petitioners, the 1st petitioner submitted an application for survey of the above mentioned land and paid necessary charges for survey as seen from the E-Challan produced in the typed set of papers. Since the respondent have not considered the representation of the petitioners for survey, they are before this Court.

3. Mr.RA.Gopinath, learned Standing Counsel takes notice for the 1st respondent and Mr.S.J.Sathik Mohamed, learned Government Advocate takes notice for the 2nd respondent.

4. The learned Government Advocate, who is taking notice for the 2nd
