ORDER

(Order of the Court was made
by the Hon'ble Acting Chief Justice)

Alleging that respondents 4 and 5 have put up encroachments on both sides of the main entrance of Government Hospital Road situate at Hospital Road, Madurantagam, Chengalpattu District, the petitioner sent a representation on 29.5.2024 to respondents 1 to 3 seeking removal of the said encroachment. As no action was taken based on the said representation, the present writ petition is filed.

Considering the narrow scope of the prayer made in the writ petition, without going into the merits of the matter, we direct respondents 1 to 3 to consider the representation of the petitioner dated 29.5.2024 and pass appropriate orders, on merits and in accordance with law, of course after affording an opportunity to all the interested persons, including respondents 4 and 5.
